ARTICLES OF ORGANIZATION
OF
GOODSPORTS LWR SPORTS CAMPUS, LLC

The undersigned person, acting as the organizer of GOODSPORTS LWR SPORTS CAMPUS, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on January 1, 2012 and the existence of the company shall be perpetual.

ARTICLE IX - TERMINATION OF MEMBERSHIP INTEREST


