ARTICLE IX - TERMINATION OF MEMBERSHIP INTEREST

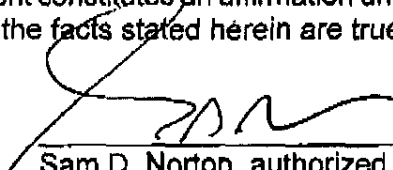
