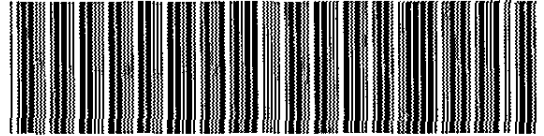

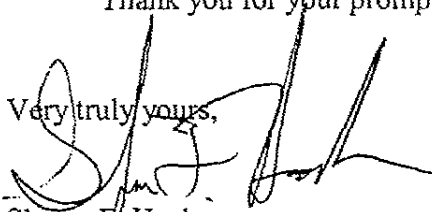

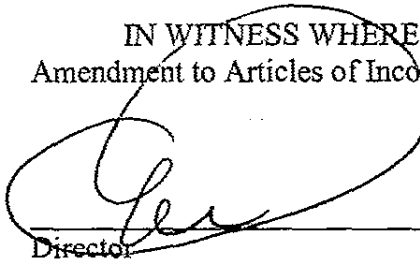
THE UNDERSIGNED, being a director of Americabilia.com, Inc. hereby amends

was sufficient for approval.

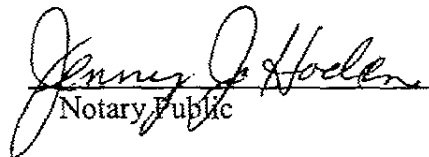
