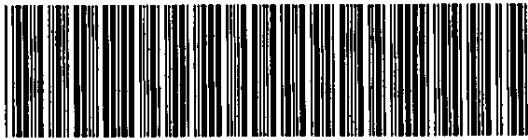

This Letter is to inform you that the Amendment filed on February 12, 2018 was filed without approval, consent, knowledge or authorization from myself Bart E. Cason or Daniel J. Croley, Jr. who are the Sole Managers and Trustees of the Walker and Brooks Irrevocable Trust utd 12/31/2011, which owns and controls Alice's Parkside Investments, LLC. This Amendment also does not contain either one of our signatures, which is required for this amendment to have been filed and to be considered valid. Alice Walker is not the owner, manager, trustee or authorized signer of this company to have the authority to add a new member or remove an existing member by filing and signing an Amendment to the Articles of Organization for Alice's Parkside Investments, LLC.

Alice Walker was misled to believe she is an owner of the company and has this authority. However, the Walker and Brooks Irrevocable Trust utd 12/31/2011, is the sole owner of this business and property the business is located on. The two trustees Bart E Cason and Daniel J. Croley, Jr. are the sole trustees and have sole control over the trust and what is owned by the trust. Attached you will find a copy of the current vesting deed into the company for the property of this business, the page from the trust stating the trustees and their powers and the pages from the LLC Operating Agreement which states the company is owned by the trust and controlled by the trustees who are also to be the managers of this company.

Please note that Bart E Cason and Daniel J Croley, Jr are the only ones who have the power to add, remove or make changes to and from this company. Therefore, if an amendment is submitted and it does not contain one of our signatures it is to be considered invalid and fraudulent. Therefore, in the future, if either Alice Walker or Sam Jackson Cason, Sr. submit an additional amendment to make unauthorized changes again to this company the trustees will be left with no alternative but to seek legal action against both.

This new Amendment to the Articles of Organization is being filed is to change the physical and mailing address of the company, change the address for Bart E Cason, add back Daniel J Croley, Jr as a manager and trustee and remove Sam Jackson Cason, Sr. as manager and trustee.
