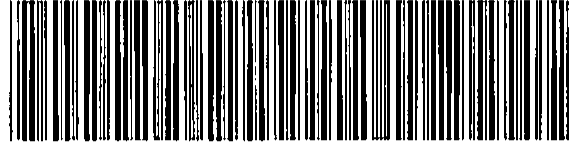



Sam Jackson Cason, Sr. is not the owner or manager of Alice's Parkside Investments, LLC and does not have the right or authority to dissolve this company. Sam Jackson Cason, Sr., Rose Cason and Sam Jackson Cason, Jr., believe they have rights and ownership in this company through the fraudulent and invalid Sunbiz Amendments and chain of deeds they have created and recorded in the Official Records of Alachua County. In addition, ownership to a company is not conveyed or transferred through a deed, even if valid. Therefore, they have no ownership or rights to make changes to this company or dissolve it.

The only ones who have authority to make changes, dissolve and reactivate this company are Bart E Cason and Daniel J Croley, Jr. the actual legitimate managers of this company.
