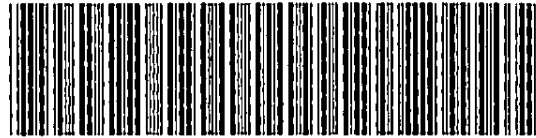

Again, the invalid and fraudulent Sunbiz Amendments and deeds he has recorded along with his wife Rose Cason do not give them legal ownership to this company. Again, the only two individuals who have legal rights to make any changes to this company are the legitimate Managers, Bart E Cason and Daniel J Croley, Jr.

On May 15, 2020, we appeared in Alachua County Court for Case No. 2020-CA-01115 Alice's Parkside Investments, LLC vs. Sam Jackson Cason, Sr, Rose Camilia Cason and Sam Jackson Cason, Jr. before Honorable Judge Monica Brasington. We were seeking an Order of Temporary Injunctive Relief in hopes of stopping all the submission and recording of fraudulent documents.

The Judge ruled in our favor and ordered that the defendants stop interfering with Alice's Parkside Investments, LLC, which included no more filing of documents to Department of State, Division of Corporations to include Sunbiz. Attached you will find a copy of this Order Granting Plaintiff's Motion for Temporary Injunctive Relief. I am in hopes this will be the last time we have to file a Revocation of Dissolution.



**ORDER GRANTING PLAINTIFF'S MOTION FOR  
TEMPORARY INJUNCTIVE RELIEF**

The Motion for Temporary Injunction Relief by Plaintiff, Alice's Parkside Investments, LLC, came before the court for hearing on May 15, 2020. Plaintiff, Alice's Parkside Investments, LLC, represented by counsel Maurice T. McDaniel, Esquire; Defendants, Sam Jackson Cason, Sr., Rose Camelia Cason, and Sam Jackson Cason, Jr. appeared Pro Se. On considering the evidence received and the argument of counsel and Pro Se parties, the Court finds and concludes that this application should be granted in that Plaintiff, Alice's Parkside Investments, LLC, demonstrated by the evidence that: (1) Plaintiff has a substantial likelihood of success on the merits to prevail; (2) That the behavior of the Defendants has left Plaintiff no adequate remedy at law; (3) There is a likelihood of irreparable harm based on the Defendants' behavior; (4) That this Injunction serves the public interest by keeping an ongoing business intact and operating.

**IT IS THEREFORE ORDERED** that from the date of entry of this order until further order of this court, the Defendants, officers, agents, servants, employees, attorneys, and all persons in active concert or participation with them are prohibited from: (1) Interfering with the business of Alice's Parkside Investments, LLC; (2) Filing deeds concerning the real property referencing Alice's Parkside Investments, LLC or the legal description related to that property; (3) Filing documents with the Department of State, Division of Corporations to include SunBiz relating to Alice's Parkside Investments, LLC; (4) Contacting utility providers, customers, accountants, vendors, agents, independent contractors, or any other third party working for or servicing Alice's Parkside Investments, LLC. about any business, transaction, or conduct relating to Alice's Parkside Investments, LLC.

**IT IS FURTHER ORDERED** that this order shall not be effective unless and until Plaintiff, Alice's Parkside Investments, LLC, executes and files with the clerk of this court a surety bond in the amount of five thousand dollars (\$5000.00) conditioned for the payment of costs and damages sustained by Defendants Sam Jackson Cason, Sr. and Rose Camelia Cason, and Sam Jackson Cason, Jr. if Defendants Sam Jackson Cason, Sr. and Rose Camelia Cason, and Sam Jackson Cason, Jr. is wrongfully enjoined.

The clerk shall on the filing by Plaintiff, Alice's Parkside Investments, LLC of the bond required by the order certify a copy of this order for service on Defendants, Sam Jackson Cason, Sr. and Rose Camelia Cason, and Sam Jackson Cason, Jr.
