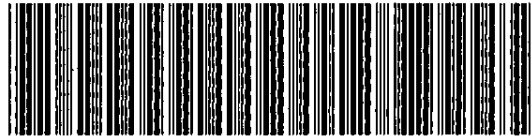

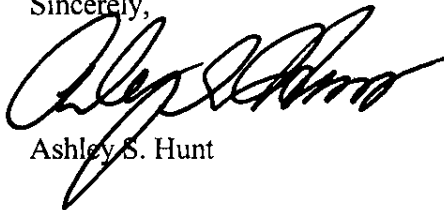

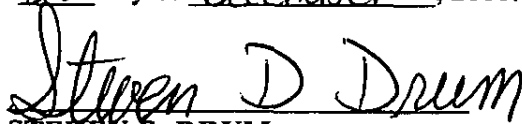
ARTICLE VI
