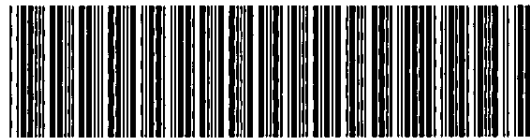

ARTICLE II

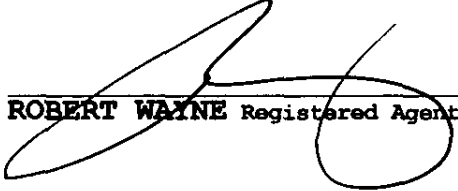
