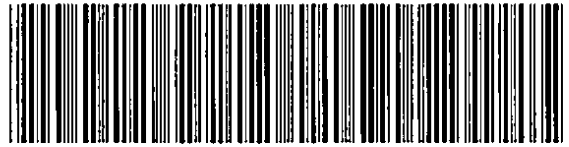

FIRST: The names of the entities that are parties to the merger are TRUSTPOINT CONSULTING, LLC, a Georgia limited liability company ("TrustPoint GA"), and OPTIMUM HEALTHCARE IT, LLC, a Florida limited liability company ("Optimum FL").



FIFTH: The effective date and time of the merger shall be: 12:01 a.m., January 1, 2022.


