AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF VERITAS PALM BEACH, LLC

We, the undersigned natural persons competent to contract, hereby organize and form a limited liability company under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of this limited liability company shall be VERITAS PALM BEACH, LLC

ARTICLE 2.

Period of Duration

The existence of the Company shall be perpetual from the date of filing the Articles of Organization with the Department of State on or about January 4, 2012 unless terminated by vote of the members.

ARTICLE 3.

Purpose

The Company is organized for the purpose of transacting any and all lawful business which imited liability companies may transact pursuant to Chapter 608, Florida Statutes.

ARTICLE 4.

Place of Business and Registered Agent

The street address and mailing address of the initial business office of the Company is 266 Iris Drive, Jupiter, Florida 33458, and the name and address of the initial registered agent of the Company is CAROLYN B.
