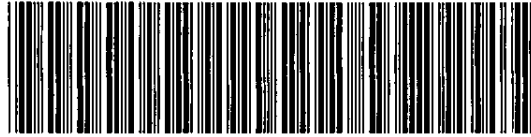


RESIGNATION OF THOMAS D. BERNARD
