REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Joseph R. Moreau, 9389 SW 14th Avenue, Ocala, FL 34496.

ARTICLE VI

CAPITAL CONTRIBUTIONS

The initial member of the Company shall contribute to the capital of the Company the sum of \$1,000.00.

MANAGEMENT

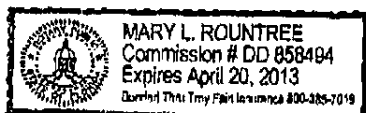
