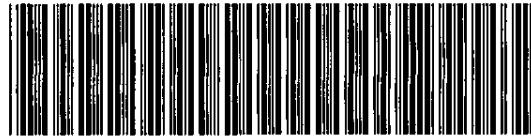



ARTICLES OF ORGANIZATION

OF

GREEN & PIOTRKOWSKI, PLLC

The undersigned subscribe to these Articles of Organization to form a professional limited liability company under the laws of the State of Florida.

ARTICLE I

The name of the professional limited liability company shall be GREEN & PIOTRKOWSKI, PLLC and its initial post office address and its principal office for the conduct of business is 317 - 71<sup>st</sup> Street, Miami Beach, FL 33141.

ARTICLE II

The general nature of the business to be transacted by this professional limited liability company is:

- (a) To engage only in every aspect and phase of the business of rendering professional legal services to the general public and to do all things in connection therewith that are customarily done by licensed lawyers under the laws of the State of Florida.
