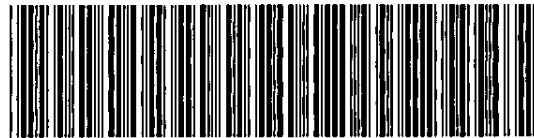

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **COOPER PUBLIC RELATIONS, LLC** ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 10918 Eliotti Street, Orlando, Florida 32832 and the mailing address shall be the same.

**ARTICLE 3 - EFFECTIVE DATE**

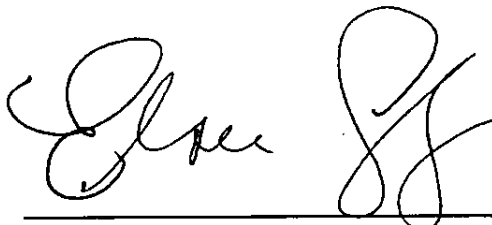

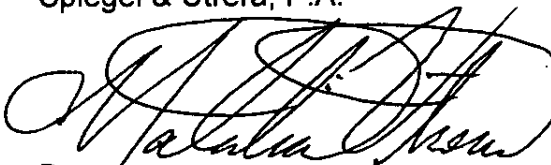
