**ARTICLES OF ORGANIZATION**  
**OF**  
**FOUNDERS CLUB FUNDING COMPANY II, LLC**

The undersigned person, acting as the organizer of FOUNDERS CLUB FUNDING COMPANY II, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**

The name of this limited liability company is:

FOUNDERS CLUB FUNDING COMPANY II, LLC

**ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE**

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

**ARTICLE III - PURPOSE**

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE**

#### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admissions shall be restricted in accordance with the terms and conditions as shall be set forth in the company's operating agreement.

#### ARTICLE VII - MANAGEMENT BY MANAGER

The company shall be managed by one or more managers upon such terms and conditions as shall be set forth in its operating agreement.

#### ARTICLE VIII - REGULATIONS

The power to adopt, alter, amend, or repeal the regulations of the company in the form of an operating agreement or otherwise is vested exclusively in the members of the company.

#### ARTICLE IX - TERMINATION OF MEMBERSHIP INTEREST


The company shall not be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.

#### ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION

Any amendment to the Articles of Organization shall be approved by the prior written consent of at least seventy-five percent (75%) of the total issued and outstanding membership interests in the company in accordance with the terms and conditions as shall be set forth in the company's operating agreement and shall be as prescribed by the Secretary of State of the State of Florida.


**ACCEPTANCE OF REGISTERED AGENT**
