AMENDED AND RESTATED ARTICLES OF ORGANIZATION of HILLTOP DAIRY HOLDINGS, LLC

ARTICLE I

The name of the limited liability company shall be HILLTOP DAIRY HOLDINGS, LLC (the "Company"). The mailing address and principal office of the Company in Florida shall be: 4951 N.W. 170th Street, Trenton, Florida 32693.

ARTICLE II PURPOSES AND POWERS
