The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE 1 - NAME

The name of the limited liability company shall be **DITELMARSE LLC** ("Company").

#### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be Cabello 3966, Capital Federal, Argentina 1425 and the mailing address shall be the same.

#### ARTICLE 3 - EFFECTIVE DATE
