ARTICLES OF ORGANIZATION
OF
RIVERVIEW KIDCARE, LLC

1. Name. The name of this limited liability company is **RIVERVIEW KIDCARE, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company shall be effective on filing of these Articles, and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is **10420 U.S. HIGHWAY 301 SOUTH, RIVERVIEW, FLORIDA 33578.**

5. Registered Agent and Office. The name of the initial registered agent of the Company is **PATRICIA HOEPNER**. The street address of the initial registered agent of the Company is **10420 U.S. HIGHWAY 301 SOUTH, RIVERVIEW, FLORIDA 33578.** The Company shall have the right to change such registered agent and such registered office from time to time, as provided by law.


6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by its members at this time. No contributions have been agreed upon.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be managed in accordance with the operating agreement adopted by the members. The initial member shall be **PATRICIA HOEPNER**. Until and unless changed by the operating agreement, **PATRICIA HOEPNER** shall be the sole managing member of the Company, and she shall have full power and authority to act for and on behalf of the Company, including, without limitation, to enter into contracts, open and close bank accounts, incur and pay debts and expenses, file papers with the Internal Revenue Service, and engage consultants, managers, and professionals and other advisors, and all persons may rely on these Articles of Organization to deal directly with this named individual and the persons she designates on all matters relating to the Company.
