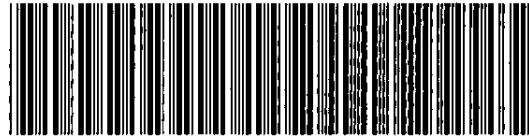

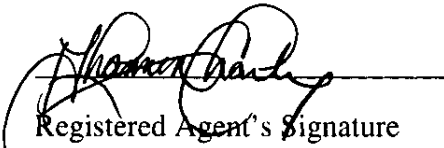

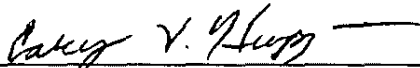
ARTICLE VI. DURATION
