THIS IS TO CERTIFY THAT:

FIRST: This Amended and Restated Articles of Organization amends and restates the Articles of Organization of SOLACE BEHAVIORAL HEALTH, LLC.

SECOND: The original Articles of Organization of SOLACE BEHAVIORAL HEALTH, LLC were filed with the Florida Department of State on January 13, 2012, and assigned Document Number 112000006682.


