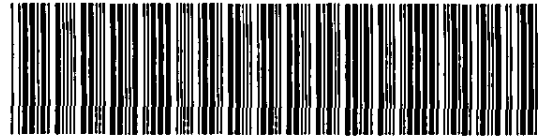

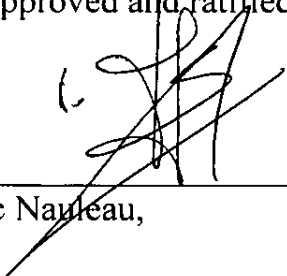

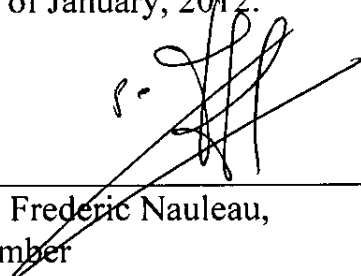
**ARTICLES OF DISSOLUTION
