The mailing address and street address of the Company is 1111 Metropolitan Avenue, Suite 700, Charlotte, North Carolina, 28204.

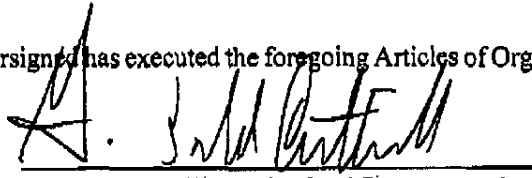
**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**

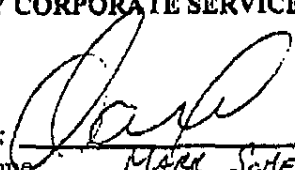
