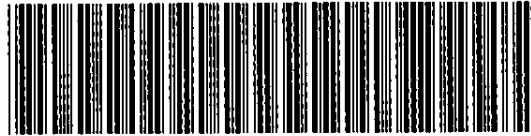

**ARTICLES OF ORGANIZATION
OF
CIW CONSULTING, LLC**

1. Name. The name of this limited liability company is **CIW CONSULTING, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The mailing address of the Company is **P.O. Box 9446, Bradenton, Florida 34206**, and the street address of the Company's principal office is **c/o Foley & Lardner LLP, Attn: Randolph J. Wolfe, 100 N. Tampa Street, Suite 2700, Tampa, Florida 33602**.


