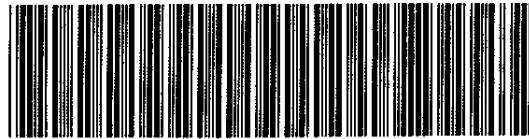

NAME
