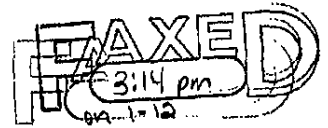

ARTICLE I - NAME

ARTICLE V - MANAGEMENT OF THE COMPANY




