ARTICLE I

The name of this professional limited liability company shall be Stone Lockett, P.L., a Florida professional limited liability company.

ARTICLE II

Stone Lockett, P.L. shall have perpetual existence.

ARTICLE III

Stone Lockett, P.L. is created to conduct business as a Law Firm and may engage in the transaction of any or all lawful businesses for which limited liability companies may be formed under the laws of the State of Florida.

ARTICLE IV




