

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I Name

The name of the limited liability company is J & W Motors, LLC ("Company").

ARTICLE II Address

The mailing and street address of the Company's principal office is 870 Old Dixtornal Highway, Suite 10, Lake Park, Florida 33403.

ARTICLE III Duration

The period of duration for the Company is perpetual beginning on the date of Articles of Organization are filed by the Florida Department of State.

ARTICLE IV Registered Agent and Office

ARTICLE V Purpose
