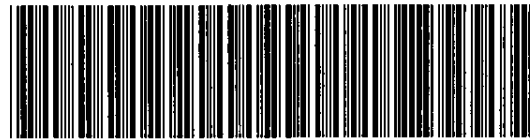



ARTICLE I - Name
