

ARTICLES OF ORGANIZATION
OF
MILLMAX, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **MILLMAX, LLC**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 87 NW 39th St Ct, Bradenton, Florida 34205.

ARTICLE III - DURATION

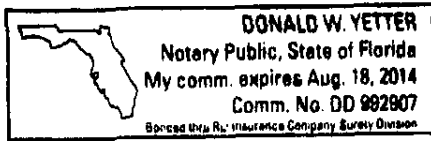


