ARTICLE 1 - NAME

The name of the limited liability company shall be **A REALTOR'S FRIEND, LLC** ("Company").

ARTICLE 2 - ADDRESS

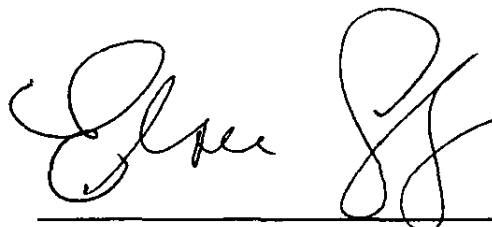

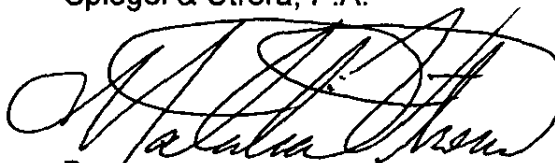
