ARTICLES OF ORGANIZATION
OF

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is BEACHSIDE LINEN SERVICES, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 127 Bud's Lane, Santa Rosa Beach, Florida, 32459, and its mailing address is P.O.
