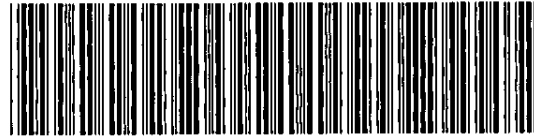

ARTICLE I - Name

The name of the limited liability company is **PFT-TALLAHASSEE, LLC**


ARTICLE V - Admission of Additional Members
