**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be 3810 26<sup>th</sup> Street, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 2581 67<sup>th</sup> Terrace North, St. Petersburg, Florida 33702.

**ARTICLE II**

**PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The managers shall be elected in the manner set forth in the Operating Agreement of the Company.
