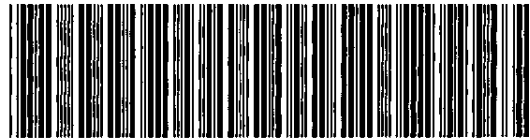



ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
IFP ADVISORS, LLC

The undersigned being Authorized Representative of the sole Member and the Manager of IFP ADVISORS, LLC., a Florida limited ed liability company (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is IFP Advisors, LLC
2. The Articles of Organization for the Company were filed with the Florida Department of State on January 25, 2012.

3. Article V of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE V.

"The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The authority and duties of the Managers shall be as set forth in the Operating Agreement of the Limited Liability Company. The names and address of the initial Manager is William E.
