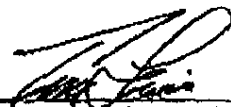
ARTICLE VI - MANAGEMENT

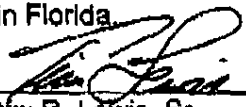

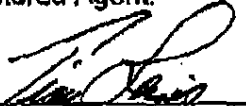
