ARTICLES OF ORGANIZATION

Effective at 12:01 a.m. on the date of this filing, EYEGASP.COM, LLC a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby submit the following Articles of Organization pursuant to and in accordance with Sections 608.407 and 608.4081, *Florida Statutes*.

Article 1
NAME

The name of the limited liability company shall be EYEGASP.COM, LLC.

Article 2
DURATION

The period of duration of the Limited Liability Company shall be perpetual, unless the Limited Liability Company is dissolved pursuant to the provisions of the Florida Limited Liability Company Act, these Articles of Organization, or the then-existing Operating Agreement of the Limited Liability Company.

Article 3
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

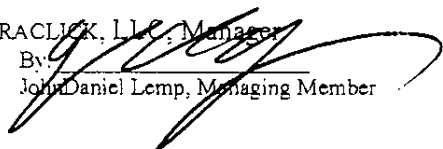
