FIRST: The Articles of Organization were filed on the 30th day of January, 2012 and assigned document number L12000014240.

SECOND: That Article VII of the Articles of Organization are hereby amended and restated to read as follows:

**ARTICLE VII
MANAGEMENT OF THE COMPANY**
