ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF FD VERNON, LLC

FIRST: The Articles of Organization were filed on the 30th day of January, 2012 and assigned document number L12000014240.

SECOND: That Article VII of the Articles of Organization are hereby amended and restated to read as follows:

ARTICLE VII MANAGEMENT OF THE COMPANY

This Company will be managed by manager(s) appointed by the members in accordance with the terms of the operating agreement. As such, the Company will be manager-managed. The Company may also designate personas as Officers or Directors, under the Operating Agreement, who shall act in a manner similar to officer or directors of a corporation.
