



ARTICLE I—Name: The name of this professional limited liability company is KAYE BENDER REMBAUM, PLLC.


ARTICLE II—Duration: This professional limited liability company shall continue in existence in perpetuity unless its existence is sooner terminated or dissolved by agreement or law.


