**ARTICLES OF ORGANIZATION
OF
PENINSULA LAND COMPANY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be PENINSULA LAND COMPANY, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 103 Flagler Avenue, New Smyrna Beach, Florida 32169.

ARTICLE III

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.


