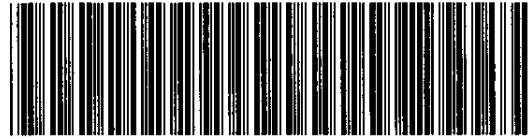



ARTICLE I
