ARTICLES OF ORGANIZATION
OF
GOLDEN EAGLE AIR, LLC

The undersigned person, acting as the organizer of GOLDEN EAGLE AIR, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

GOLDEN EAGLE AIR, LLC

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on the date these Articles of Organization are filed with the Florida Department of State, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE V - PLACE OF BUSINESS

ARTICLE VII - MANAGEMENT BY MANAGER

The company shall be managed by one or more Managers.

ARTICLE VIII - REGULATIONS

The power to adopt, alter, amend, or repeal the regulations of the company in the form of an operating agreement or otherwise is vested exclusively in the members of the company.
