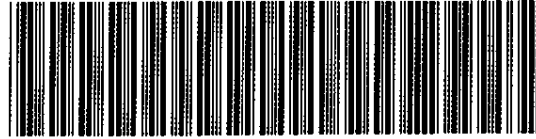

ARTICLE II - ADDRESS

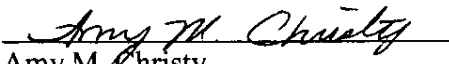

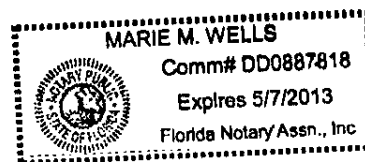
