ARTICLES OF ORGANIZATION OF FREE ELECTRON ABSORPTION 1, LLC

TALLAHASSEE FLORIDA The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

We further declare that the following Articles will serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I

Name and principal place of business. The name of the limited liability company shall be FREE ELECTRON ABSORPTION 1, LLC, and its mailing address and principal office shall be located at 4628 Delwood View Boulevard, Panama City Beach, Florida 32408, but it shall have the power and authority to establish branch offices at any other place or places as their members may designate.

ARTICLE III

Exercise of powers. All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. These Articles of the limited liability company may be amended from time to time by unanimous vote of the members of the limited liability company.
