ARTICLES OF ORGANIZATION OF

HJ REALTY, LLC

The undersigned, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby acknowledges and files the following Articles of Organization.

ARTICLE I: Name

The name of the limited liability company is HJ REALTY, LLC (the Company).
