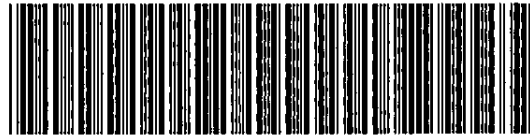

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be: **B&B LAWN CARE OF LEE COUNTY, L.L.C.**

**ARTICLE II

The power to alter, amend or repeal these regulations shall be vested in all the members of this company.


#### ARTICLE VI PROPERTY


