**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

Pursuant to Title 36, Section 608.411, of the Florida Limited Liability Company Act, the undersigned representative of the Sole Member of Florida Collaborative for Health Care Quality, LLC, (hereinafter also referred to as the "Company" or the "limited liability company"), a limited liability company organized and existing under the laws of the State of Florida, does hereby certify that the amendments incorporated herein were duly adopted by unanimous vote of the Board of Managers of the Company on March 29, 2012, and duly adopted by unanimous vote of the Sole Member of the Company on March 29, 2012, for the purpose of amending and restating the Articles of Organization of the Company. 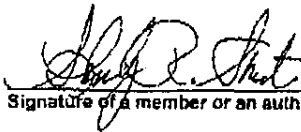
