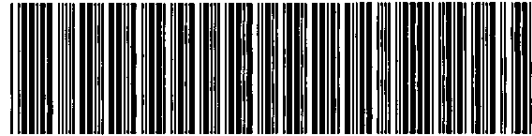

**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
Name**

The name of the limited liability company is PGA TOUR Latinoamerica, LLC (hereinafter referred to as the "Limited Liability Company").

**ARTICLE III
Purpose**

The purpose for which this Limited Liability Company is organized is any and all lawful business.

The Limited Liability Company shall not engage in any business of a kind ordinarily carried on for profit, even though conducted on a co-operative basis, or so as to produce sufficient income only to be self sustaining. No part of the Limited Liability Company's net earnings shall inure to the benefit of any shareholder or individual.

In furtherance to its corporate purposes, and not to conduct business for profit, to construct, purchase, lease and otherwise acquire, own, manage, mortgage, sell, assign, dispose of and deal in and with real property and any interest in real property including, but not limited to, golf courses, golf club houses, golf driving ranges and golf chip and putt courses, and with goods, merchandise and personal property of every character and description.

In furtherance to its corporate purposes, and not to conduct business for profit, to produce, exhibit, distribute and sell television, radio, motion picture and other products.

ARTICLE IV
Non-Stock

The Limited Liability Company shall be without capital stock and will not be operated for profit.

The Limited Liability Company is a non-stock Limited Liability Company which does not have stockholders.

ARTICLE V
Duration

The period of duration for the Limited Liability Company shall be perpetual.

In the event of any dissolution of the Limited Liability Company any assets remaining after payment of all debts shall be distributable, to one or more organizations whose purposes are similar, if no organization exists, or if no organization is determined to be an appropriate recipient of the Limited Liability Company's remaining assets, said assets shall be distributable to an organization or organizations, exempt from Federal income tax, which promotes the interest of professional golfers and the game of golf.

No member of the Limited Liability Company shall be liable under a decree or order of a court or in any other manner for a debt, obligation or liability of the Limited Liability Company.

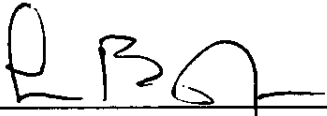
ARTICLE IX

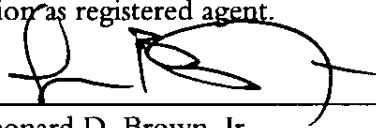
**CERTIFICATE OF DESIGNATION OF
