**ARTICLES OF ORGANIZATION  
OF  
AF AURORA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I. NAME**

The name of the limited liability company is AF Aurora, LLC (the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 1400 NW 107<sup>th</sup> Avenue, 5<sup>th</sup> Floor, Miami, Florida 33172.

**ARTICLE III. REGISTERED AGENT AND OFFICE**


**ARTICLE IV. DURATION**
