**ARTICLES OF ORGANIZATION OF  
CLEANING AND RESTORATION SERVICES OF THE GULF COAST, LLC**

The undersigned, RAYMOND B. FRENCH, a natural person competent to contract and a member of CLEANING AND RESTORATION SERVICES OF THE GULF COAST, LLC, hereby presents these Articles of Organization of CLEANING AND RESTORATION SERVICES OF THE GULF COAST, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is CLEANING AND RESTORATION SERVICES OF THE GULF COAST, LLC. This limited liability company is referred to herein as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE VI - MANAGEMENT**

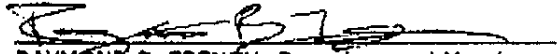

**ARTICLE VII - AMENDMENT**

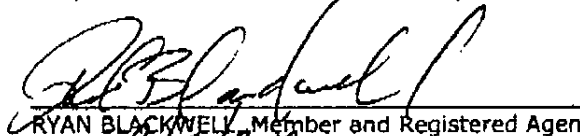
